## Terms and Conditions

### Definitions

- This event is organised through Neroche Woodlanders Ltd in collaboration with Jenny Archard and Fern Smith
- NWL shall mean Neroche Woodlanders Ltd whose registered address is 10 Sunnyside, Awliscombe, Honiton EX14 3NX (Industrial Provident Society, Register no. 31925R);
- Staff / Volunteers / Leaders shall mean: persons that hold relevant qualifications, are experienced and have current DBS (Disclosure and Barring Check). Further details can be provided on request;
- Participant shall mean the person booking and attending the course

### Payment

- Total minimum cost is £390 to be paid by June 1st. Any deposit is non-refundable.

### Insurance and Damage

- NWL has public liability and employers liability insurance to cover our activities. Details can be seen on request. These do not cover theft, loss or breakage of personal items.
- It is the responsibility of all Participants to look after their own bags and effects. Please do not bring valuable electrical gadgets, which may be damaged by rain, mud or impact.

### Parking

- Parking is provided in the carpark at the Young Wood base. **No vehicles** should be brought to camp area unless this has been agreed with Staff.

### Health

- Please notify NWL **at the time of booking** about dietary, or medical condition, allergy or disability that may affect his Participant's involvement, so that necessary arrangements can be made to accommodate the condition.
- **Please complete the medical / consent information** and send these with your booking
- Whilst NWL will make their best efforts to accommodate every person, we cannot guarantee that these requirements will be met.

### Cancellation or Alteration

- Activities are dependent on weather conditions. NWL reserves the right to cancel, postpone or alter session activities at short notice in the event of unfavourable weather conditions. These shall include but not be limited to: high winds, heavy rain, electrical storms and snow as forecast. Participants will be contacted as soon as practicable to inform them of such changes or cancellations. If NWL cancels or postpones a session due to weather, a replacement date will be sought.
- If the Participants cancels their booking after paying a deposit **the deposit will be forfeit.**
